## **Annex 1 – Guidelines on the International First Aid Attestation (IFAA) stamp and award letter**

Congratulations for having being awarded IFAA for your first aid training!  
Here below are guidelines for a proper use of the IFAA stamp following your award.

### **I. IFAA stamp**

1. The IFAA stamp is displayed as follows. A specific file for this stamp has been addressed to the [Ukrainian Red Cross](#)



2. The [Ukrainian Red Cross](#) is entitled to use the IFAA stamp provided by the Global First Aid Reference Centre (GFARC) for the awarded [Save life first aid level 2](#) and for a five-year period starting on the IFAA award date. The IFAA award date is the date shown on the IFAA award letter signed by the GFARC Head.
3. The IFAA stamp can be displayed on the [Ukrainian Save life first aid level 2](#) certificate. A template of training certificate with the added IFAA stamp should be sent to the GFARC for archiving purposes.
4. The IFAA stamp is the only image to be used as a recognition of the IFAA award. Please note that the IFAA award does not entitle the [Ukrainian Red Cross](#) to add the GFARC logo to their [Save life first aid level 2](#) certificate.
5. The IFAA stamp cannot be used for any non-awarded first aid training(s) or training(s) or programme(s).
6. At the end of five-year period starting on the IFAA award date, the use of the stamp shall be ceased.

### **II. IFAA award letter**

1. The IFAA award letter is aimed at recognising that the IFAA has been awarded to a specific National Society for one or several of their first aid training course(s). The name of the relevant awarded National Society and course(s) are indicated on the letter.
2. The IFAA award letter is addressed to the National Society by the GFARC.
3. The IFAA award letter cannot replace the IFAA stamp.
